Control Downside Risk

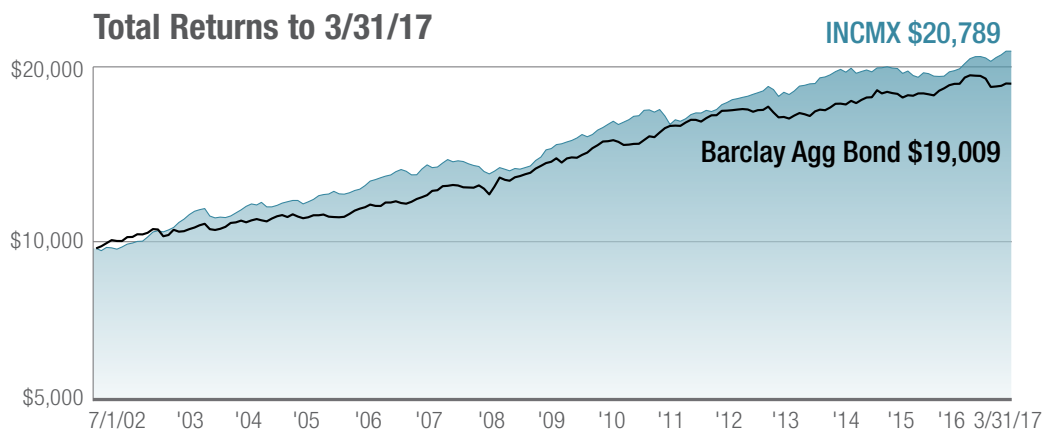

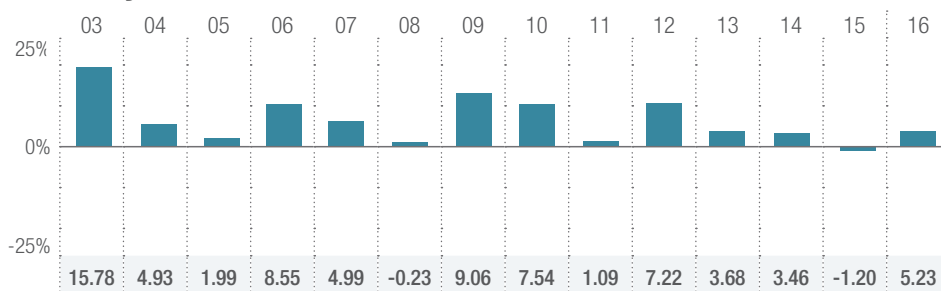
