Control Downside Risk

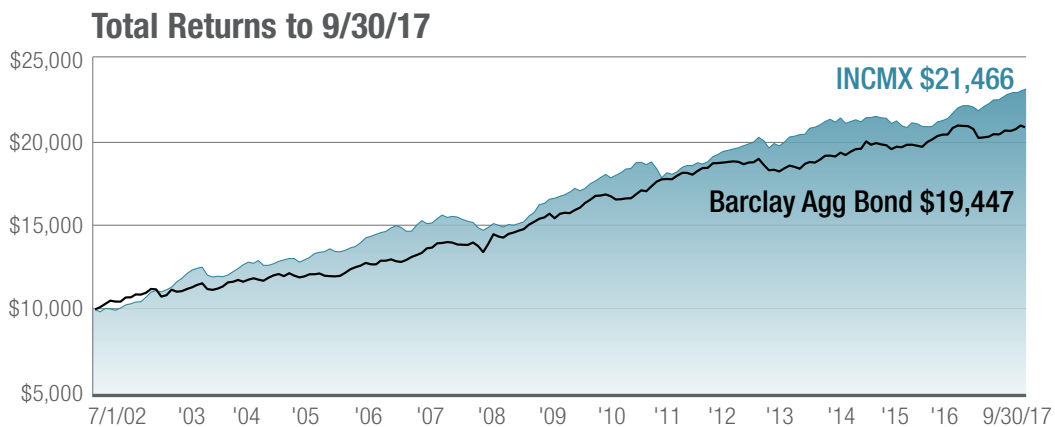

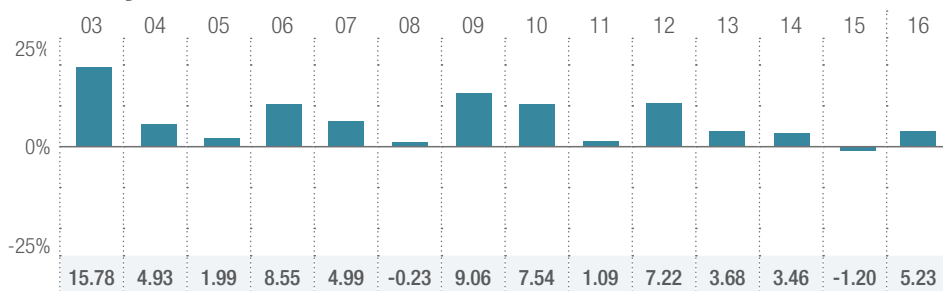
