### Control Downside Risk

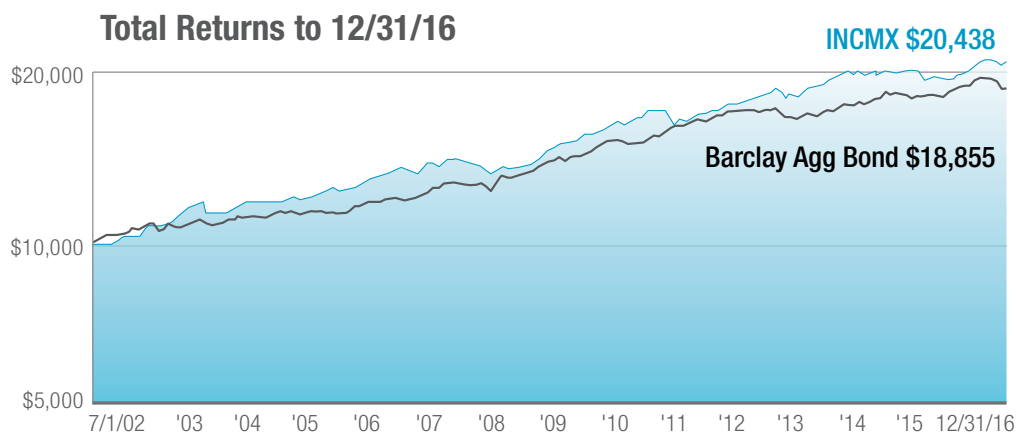

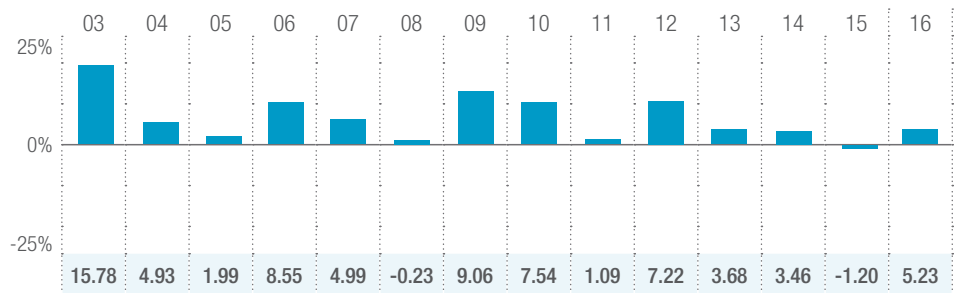
